















































































#### Technology Fast 50™ Türkiye Program



The program celebrates Türkiye's fastest growing high-technology companies. The awards identify the trends that are shaping the technology, media and telecommunications sectors today. Based on revenue growth percentage over a four year period, the program includes companies from all related industry sub-sectors:

- Communications
- Environmental Technology
- Fintech
- Hardware
- Healthcare and Life sciences
- Media and Entertainment
- Software

To be eligible for Deloitte Technology Fast 50 Program, companies must meet the following criteria:

to be a technology company which:
 has its own proprietary technology that contributes to a significant portion of the company's operating revenues

- manufactures a technology-related product devotes a significant effort to research and development about technology
- -is a technology incentive, or use unique technology to solve problems
- to be in business for a minimum of three years
- whose parent company must be <u>Turkish</u>
- owned and headquartered in Türkiye
- whose operating revenues must be at least
- €30,000 for 2020 and €500,000 in 2022.
